Division qualifications

Elite

- 100 points Elite regular
- 20 points in each of the following Elite classes: Jumpers, Touch N Go, Tunnelers, Weavers

Pre-Elite

- 100 points in Open or Elite regular, with no more than 40 points in Elite regular
- 20 points in Open or Elite Jumpers, Touch N Go, Tunnelers, Weavers

Frequently Asked Questions Answered

- There are two class divisions and three height divisions.
- Elite 4-8", 12", 16/20" Pre-elite 4-8", 12", 16/20"
- To qualify for Pre-Elite you cannot have accumulated more than 40 points in Elite regular, but you can have more than that in all of the other Elite classes
- The entry form will be available after August 14, 2023.
- You must be an Arizona resident to participate in this Invitational Classic, priority given to JCAC members, then other Arizona residents
- There will be a limit of 60 dogs that can be entered in the Classic
- Courses will be of normal length (18-20 obstacles) with some interesting challenges. All dogs run the same courses.
- Each dog will run 7 times. Each run will start with 250 points. From that score time plus faults are subtracted. (ex. Dog ran course in 45.10 seconds and got 10 faults. 55.10 would be subtracted from 250 for a score of 194.9 for that run).
- To determine the winners, scores from all 7 runs will be added together. The highest score wins the class.
- You CAN earn NADAC regular Q's on these runs. You still need to have fewer than 5 time or course faults. Each of the 7 courses can earn you a separate Q...or not!
- The run order is alphabetical (for the most part) on runs 1-6. Sunday morning's runs are seeded...with the dog in first place for their jump height and division running last and the last place dog running first.
- Awards will be given for 1st 3rd place in each jump height and division (4/8", 12", 16/20").
- We will rotate which jump height starts each run.
- The winner of each HEIGHT division is whomever has the highest score over all 7 rounds combined.

JUMP HEIGHTS

There are four Standard Division-Proficient jump heights: 8", 12", 16", and 20".

There are four Standard Division-Skilled jump heights: 4", 8", 12", and 16".

There are four jump heights for the Veterans and Junior Handler divisions: 4", 8", 12", and 16".

Brief Summary of Rules:

Please refer to www.nadac.com for a full explanation of all NADAC rules and up to date information.

- Please note that NADAC trials should provide a safe and fun environment for both exhibitors and their dogs.
- Aggressive dogs will not be tolerated and will be excused from the trial.
- The show committee has the right to refuse any entry. Anyone not currently in good standing with NADAC will not be allowed to enter this trial.
- Exhibitors, through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations, and agree to abide by all rules in effect at the time of this trial.
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Checks not honored by the bank do not constitute a valid entry fee. There will be a \$25.00 service charge for bank returned checks.
- Dog must be registered and have a valid registration number before entries will be accepted. https://www.nadac.com/register-your-dog/
- A copy of the current Exhibitors Handbook may be downloaded free from the NADAC web site: www.nadac.com
- Bitches in heat, lame, or blind dogs are ineligible for entry, as is any dog with a deformity which may cause a
 judge to not be able to reasonably assess the dog's ability to function and perform agility obstacles safely,
 and in a manner that is in the best interest, health and welfare of the dog.
- No food, clickers, or other aids or devices shall be permitted on the course or within 10 feet of the ring. Food or a small non-audible toy can be in a secure container (ziplock bag is acceptable) in your pocket during your run but it cannot be used during your run, nor can you indicate to the dog it is there. All handlers may bring a non-audible toy into the ring for training purposes. They cannot earn a Qualifying score and must declare to the judge they are training before they commence their run. Please read the Exhibitor's Handbook for more information about toys and training in the ring.
- The sponsoring clubs will not be responsible for the loss or damage to any dog exhibited, or for the
 possessions of any exhibitor whether the result be accident or other cause. It is distinctly understood that
 every dog at this event is in the care and control of his owner or handler during the entire time the dog is on
 the show premises.

AGREEMENT

- 1.3. Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
- 1.4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the surface, restrooms, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.
- 1.5. Exhibitor/owner releases NADAC (including its respective officers, directors, employees, and members), and Jumping Chollas Agility Club (including its officers, directors, members, and event organizing committee and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. 
