Arizona 500

Need 4 Speed Challenge

What is it: The **Arizona 500 Need 4 Speed Challenge** will consist of both Rounds of Sat. Nov. 29th Touch n Go & both Rounds of Sun. Nov. 30th Tunnelers.

Who can enter: All Elite, Open, & Novice dogs may enter. The courses for both TnG & Tun. are the same for all 3 levels. No worries if you are in different levels (**No Intro as the course is different**).

How does it work: Since the courses are the same, all levels will compete against each other. There will be 3 height divisions Small, Medium, & Large to help keep the competition fun & fair.

- Height divisions are based on the dog's wither heights noted on their premium. If a question of a dog's height occurs the dog will be measured at the event.
 - Small (dogs 14" & under)
 - Medium (dogs over 14" up to & including 18")
 - Large (dogs over 18")

Scoring: Each dog will be given 500 base points for the event. Time and course faults from each run will be subtracted from the base points. Eliminations, Scratches, & DNRs will result in a score of zero for that run.

Example:	Base Points	500pts
	TnG times (Rd1/Rd2):	- (20sec + 25sec) =
		- 45 sec
	TnG course faults (Rd1/Rd2):	- (0 + 10) =
		- 10 faults
	Tun. times (Rd1/Rd2):	- (15sec + 20sec) =
		- 35 sec
	Tun. course faults (Rd1/Rd2):	- (0 + 10pts) =
		- <u>10 faults</u>

Dog's total score for the event: **400 pts**

Tiebreaker: In case of a points tie, time will be used to determine the winner. Fast combined times of all 4 rounds ***Wins***.

Tiebreaker Example:

Dog 1: Tng Rd1 20sec + Rd2 25sec + Tn Rd1 15sec + Rd2 20sec = (80sec)

Dog 2: Tng Rd1 20sec + Rd2 20sec + Tn Rd1 15sec + Rd2 15sec = (70sec) **WINNER of tiebreaker**

Placements: Highest 3 scores win. First, Second, & Third place will be announced for each Height Division.

Prizes: Winners are awarded by percentage shown below of the amount of entries in their Height Division.
If only one competitor is in a height group, they will be refunded their \$5 entry.

- **1st place 50%**
- **2nd place 30%**
- **3rd place 20%**

Cost: \$5 per dog (***All who enter must pay \$5 & No JCAC bucks or other discounts can be used for Special Event entry***)

There will be no refunds for entries withdrawn after one week before the show or in the event a dog and/or handler are dismissed from competition, regardless of the reason for such dismissal.

A withdrawal from the competition due to a bitch coming into season after the closing date will be eligible for a refund up to 75% of the total entry fee paid.

No entry fee refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, an act of God, public emergency and act of public enemy, or any other cause beyond the control of the organizing committee.

Dogs cannot be officially measured before 2 years old but must be measured by the time they are competing in Elite.

JUMP HEIGHTS

There are four Standard Division-Proficient jump heights: 8", 12", 16", and 20".

There are four Standard Division-Skilled jump heights: 4", 8", 12", and 16".

There are four jump heights for the Veterans and Junior Handler divisions: 4", 8", 12", and 16".

Brief Summary of Rules:

Please refer to www.nadac.com for a full explanation of all NADAC rules and up to date information.

- Please note that NADAC trials should provide a safe and fun environment for both exhibitors and their dogs.
- Aggressive dogs will not be tolerated and will be excused from the trial.
- The show committee has the right to refuse any entry. Anyone not currently in good standing with NADAC or with JCAC will not be allowed to enter this trial.
- Exhibitors, through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations, and agree to abide by all rules in effect at the time of this trial.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Checks not honored by the bank do not constitute a valid entry fee. There will be a \$25.00 service charge for bank returned checks.
- Dog must be registered and have a valid registration number before entries will be accepted. <https://www.nadac.com/register-your-dog/>
- A copy of the current Exhibitors Handbook may be downloaded free from the NADAC web site: www.nadac.com
- Bitches in heat, lame, or blind dogs are ineligible for entry, as is any dog with a deformity which may cause a judge to not be able to reasonably assess the dog's ability to function and perform agility obstacles safely, and in a manner that is in the best interest, health and welfare of the dog.
- No food, clickers, or other aids or devices shall be permitted on the course or within 10 feet of the ring. Food or a small non-audible toy can be in a secure container (ziplock bag is acceptable) in your pocket during your run but it cannot be used during your run, nor can you indicate to the dog it is there. All handlers may bring a non-audible toy into the ring for training purposes. They cannot earn a Qualifying score and must declare to the judge they are training before they commence their run. Please read the Exhibitors Handbook for more information about toys and training in the ring.
- The sponsoring clubs will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result be accident or other cause. It is distinctly understood that every dog at this event is in the care and control of his owner or handler during the entire time the dog is on the show premises.

****Trial Code of Conduct****

JCAC trials are designed to be a fun, safe, and neutral environment, free from the everyday challenges and stresses of life. Handlers come to enjoy competing in agility with their dogs and fellow handlers. Playful banter, humor, and comical attire, as long as it's in good taste, are all acceptable at all JCAC trials.

However, unsportsmanlike behavior, including harassment of trial personnel or fellow competitors, and apparel or signage that includes hate speech, crude/vulgar language, strong political views, or anything else deemed in poor taste, will not be tolerated on trial grounds. Each case will be discussed by the Trial Committee members. If the Committee's findings result in a violation of the club's trial Code of Conduct, the person or people may be dismissed from the trial grounds. Depending on the severity of the violation, additional actions may be taken by JCAC and/or NADAC.

Also, late/day of handlers are **responsible** for talking to the Chief Ring Seward(s) to get your/dog's name on the scribe sheets & to talk to the Agility Gate Manager to get your/dog's name on Agility Gate. This needs to be done immediately after you have given your entry to the Trial Secretary.

Added Runs For Dog(s) Already Entered: We love that you are having so much fun and want to add runs. **A \$10/dog fee will be added to the \$14/run fee for adding runs day of.** You Must add those runs before the course has been set/numbered. The sooner the better please/thanks. It's also the handlers **responsible** for talking to the Chief Ring Seward(s) to get your/dog's name on the scribe sheets & to talk to the Agility Gate Manager to get your/dog's name on Agility Gate for those added runs. This needs to be done immediately after you have given your entry to the Trial Secretary. Keep in mind the CRS & AGM might be running dogs so, catch them when you can if that's the case.

1.2. Exhibitor/owner agree to abide by the rules and regulations of NADAC and any other rules and regulations appearing in the premium for this event.

1.3. Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.

1.4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the surface, restrooms, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.

1.5.
